On January 8, 2020 members of the Nashua Police Department's Narcotics Intelligence Division and Problem Oriented Policing Unit participated in a coordinated round-up where six individuals were arrested for various narcotics related crimes. These individuals were:

**Dinah Cross**, age 37, of 11 Amherst St. Apt. #4, Nashua, NH, was charged with Acts Prohibited, Sale of a Controlled Drug (Heroin), Second Offense, Special Felony. Cross was released on personal recognizance bail and is scheduled to be arraigned in the Hillsborough County Superior Court-South on January 23, 2020.

**Andrew Martines**, age 32, of 11 Amherst St. Apt. #4, Nashua, NH, was charged with Criminal Liability to Conduct of Another, Acts Prohibited; Sale of a Controlled Drug (Heroin), Class B Felony. Martines was released on personal recognizance bail and is scheduled to be arraigned in the Hillsborough County Superior Court-South on January 23, 2020.

**Daniel MacPhee**, age 66, of 3 Mullikin Rd., Merrimack, NH, was charged with 2 counts of Acts Prohibited; Sale of a Controlled Drug (Marijuana), Special Felony. MacPhee was released on personal recognizance bail and is scheduled to be arraigned in the Hillsborough County Superior Court-South on January 23, 2020.

**Harold Sherman**, age 58, of 7 Gray Ave., Nashua, NH, was charged with Acts Prohibited; Common Nuisances, Class B Felony. Sherman was released on personal recognizance bail and is scheduled to be arraigned in the Hillsborough County Superior Court-South on January 23, 2020.

**William Willhoite**, age 52, of 47 Kingston Dr., Nashua, NH, was charged with Acts Prohibited; Manufacture of a Controlled Drug (Marijuana), Special Felony. Willhoite was released on personal recognizance bail and is scheduled to be arraigned in the Hillsborough County Superior Court-South on January 23, 2020.

**Patrick Peryer**, age 30, of 21 Parker St., Manchester, NH, was charged with two counts of Acts Prohibited; Sale of a Controlled Drug (Methamphetamine), Second Offense, Special Felony. Peryer was released on personal recognizance bail and is scheduled to be arraigned in the Hillsborough County Superior Court-South on January 23, 2020.

These arrests came at the conclusion of extensive investigations into the distribution of illegal drugs in the City of Nashua.

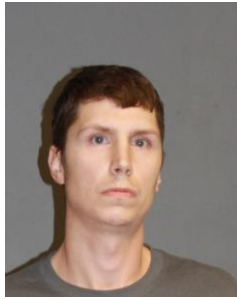
