On February 13<sup>th</sup>, 2020 members of the Nashua Police Department's Narcotics Intelligence Division and the Problem Oriented Policing Unit participated in Operation Granite Shield where five individuals were arrested for various drug crimes, and various crimes frequently associated with criminal behavior related to drug activity. These individuals were Tracey Bernazzani, Casey Vigeant, Lindsey Miron, Leo Taylor, and Katelyn Ferguson.

Tracey Bernazzani, age 48, of 46 Kinsley Street, Apartment G, Nashua, NH, was arrested and charged with 3 counts of Acts Prohibited; Sale of a Controlled Drug (Cocaine), Special Felony. Bernazzani was released on personal recognizance bail and is scheduled for arraignment in the Hillsborough County Superior Court-South on February 27<sup>th</sup>, 2020.

Casey Vigeant, age 36, of 7 Shedd's Avenue, Nashua, NH, was arrested and charged with Acts Prohibited; Sale of a Controlled Drug (Heroin), 2<sup>nd</sup> Offense, Special Felony. Vigeant was released on personal recognizance bail and is scheduled for arraignment in the Hillsborough County Superior Court-South on February 27<sup>th</sup>, 2020.

Lindsey Miron, age 35, of No Fixed Address, Nashua, NH, was arrested and charged with Acts Prohibited; Possession of a Controlled Drug (Cocaine), 2<sup>nd</sup> Offense, Class A Felony, and Acts Prohibited; Possession of a Controlled Drug (Heroin), 2<sup>nd</sup> Offense, Class A Felony. Miron was released on personal recognizance bail and is scheduled for arraignment in the Hillsborough County Superior Court-South on February 27<sup>th</sup>, 2020.

Leo Taylor, age 38, of No Fixed Address, Nashua, NH, was arrested and charged with Acts Prohibited; Sale of a Controlled Drug (Cocaine), 2<sup>nd</sup> Offense, Special Felony. Taylor was released on personal recognizance bail and is scheduled for arraignment in the Hillsborough County Superior Court-South on February 27<sup>th</sup>, 2020.

Katelyn Ferguson, age 19, of No Fixed Address, Nashua, NH, was arrested and charged with 2 counts of Acts Prohibited; Sale of a Controlled Drug (Heroin), Special Felony. Ferguson refused bail and is scheduled for arraignment in the Hillsborough County Superior Court-South on February 14, 2020.

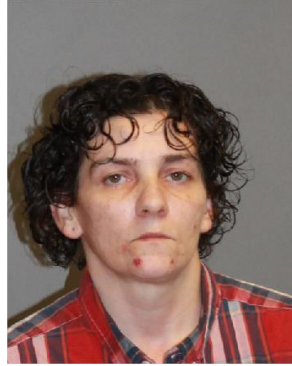

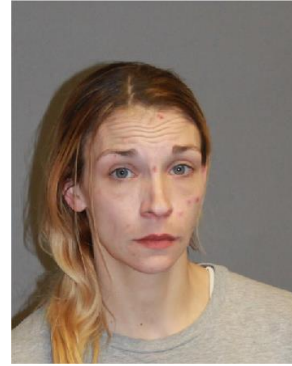
