Members of the Nashua Police Department's Narcotics Intelligence Division and Problem Oriented Policing Unit participated in Operation Granite Shield where five individuals were arrested for various drug crimes, and various crimes frequently associated with criminal behavior related to drug activity. These individuals were Harrison Duong, Manuel Escamilla, Whitney Manley, Patrick Bellot, and Cole McCloud.

Harrison Duong, age 24, of 41 Syracuse Road, Nashua, NH, was arrested and charged with Acts Prohibited; Sale of a Controlled Drug, Cocaine, 2nd Offense, Special Felony (3 Counts). Duong was released on personal recognizance bail and is scheduled to be arraigned in the Hillsborough County Superior Court-South on July 2, 2020.



Manuel Escamilla, age 27, of 80 Dodge Street, Nashua, NH, was arrested on an outstanding Out of Town Warrant for Parole Violation, Class A Misdemeanor. Escamilla was transported to the Valley Street Jail and is scheduled to be arraigned in the 9th Circuit Court Nashua District Division Court on May 28th, 2020.

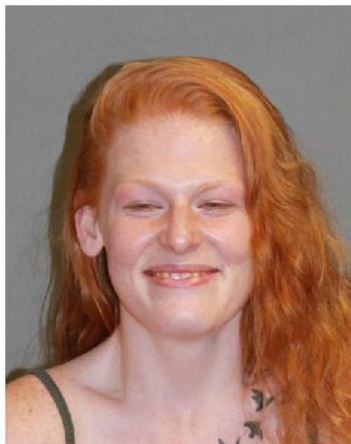
