David Lamoureux, age 31, of 24 Radcliffe Drive, Hudson, NH, was arrested on an outstanding Electronic Bench Warrant for Failure to Appear at Arraignment, and also charged with Acts Prohibited; Possession of a Controlled Drug (Methamphetamine), Class B Felony. 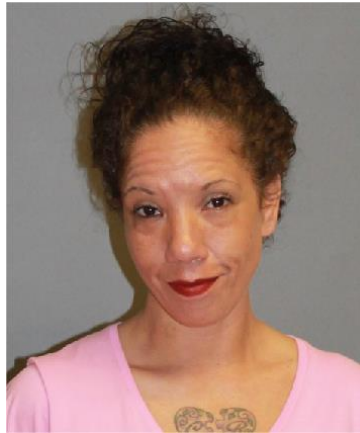
